## Minutes of the Emergent Executive Committee Meeting held at 11.00 AM on 12.01.2021, Tuesday at the Committee Hall, Centenary Building, Indian Officers' Association.

The Executive Committee meeting was chaired by Thiru. Frank Stephen Louis, President(i/c).

The Executive Committee granted leave of absence to the following Executive Committee Members.

The emergent Executive Committee meeting was convened by the President(i/c) to discuss the urgent business of the Association in respect of measures to be taken immediately by the Executive Committee following the resignations of the elected President, the elected General Secretary, one co-opted member of Executive Committee and the Hony. Warden.

The following subjects admitted by the Chair, were taken up for discussion and consideration for approval.

- 1. The Executive Committee unanimously resolved to confirm the minutes of the Executive Committee Meeting held on 31.12.2020.
- 2. The Executive Committee took note of the revised Minutes explaining the actual position of the 113<sup>th</sup> Annual General Body meeting held on 27-12-2020. The Executive Committee resolved to send detailed letters to the Chief Secretary, Government of Tamil Nadu, District Collector, Chennai, Inspector General of Registration, Chennai and the District Registrar (Central), Chennai, along with the copies of minutes of the Annual General Body meeting on 27-12-2020 and the Executive Committee meeting on 31-12-2020 in response to the ill conceived and ill motivated letters sent by Thiru. R.Karpoora sundarapandian, the then General Secretary of the Association.
- 3. The Executive Committee took note of the resolution passed in respect of salaries paid to staff of the Indian officers' Association in the Executive Committee meeting held on 12.09.2019 and unanimously resolved to approve the salary hike by 10 % on the over all salary drawn by the staff of Indian Officers' Association with effect from 01-01- 2021.
- 4. The Executive Committee, took note of the fact that there was misappropriation of Rs. 54,624/- in the expenditure relating to students hostel mess during the months of May and June 2019 and also took note of the fact that the then Executive Committee had resolved to recover the entire amount in 10 installments from the staff members concerned and effected a recovery to a tune of Rs. 18,920/-, The Executive Committee also took note of the fact that the recovery was later kept in abeyance and Thiru L.J. Singaravelan, former, Hony.Warden had conducted a fresh enquiry. The Enquiry Officer has reported that even though the charges against the individuals are proved, the delinquent staff has stated that the food was not wasted and the staff and the available students consumed excess food.
- 5. The Executive Committee, after considering all the facts relating to the issue, opined that the statement that excess food was

consumed by the staff and available students is a fragile explanation and cannot be accepted. The Executive Committee unanimously resolved as under :

- i. To call for separate explanation from Thiru P. Prakash, Manager (Accounts) for his act of ignoring the letters given by the students about their absence and the communication from the head cook to reduce the procurement of milk and suppressing the information from the then warden, thus being the root cause for the entire misappropriation and leading to financial indiscipline and colluding with others involved in the misappropriation committed.
- ii. To call for explanation from others involved in the misappropriation of IOA funds to a tune of Rs. 54,624/- for their lethargy, indiscipline and collusion.
- iii. Out of Rs.54,6254/- Rs.18,920/- was recovered, as follows:-

From Thiru V.Sundaramurthy – Rs.10,000/-, From Thiru P.Prakash Rs.3000/-, From Thiru M.Rajendran Rs.1000/-, From Thiru Chandy Abraham Rs.2460/- and from Thiru G.R.Balasubramaniam Rs.2460/-. The Balance amount of Rs. 35,704/- to be recovered in 10 instalments as follows:-

From Thiru P.Prakash Rs.1200/-per month, from Thiru M.Rajendran Rs.400/- per month and from Thiru Chandy Abraham Rs.985.20 per month.

- iv. The total amount of Rs.9852/- to be recovered from Thiru G.R.Balasubramanian from his payment due from the IOA. whose services have been terminated in view of the closure of canteen due to Covid protocol.
- v. To call for explanation from Thiru P. Prakash, Manager (Accounts) for being disloyal through his act of entering the Committee Hall during the course of the conduct of earlier Executive Committee Meeting held on 27-7-2019.
- 6. The Executive Committee, after considering the request of Tmt. S. Syamaladevi, Record Clerk of Indian Officers' Association, unanimously resolved to admit salary for the

medical leave period 08.12.2020 to 19.12.2020 (12 days) Rs.5,284/- as a special case.

- 7. The Executive Committee considered the request of Thiru. D.Gnanasekar, Room Boy and resolved to sanction additional pay at the rate of half a day salary for each day he worked from 24-03-2020 to 30-06-2020 total amount of Rs.13,883/- for the invaluable service rendered by him in the late night hours during the Covid19 pandemic.
- The Executive Committee recorded the appointment of Thiru. S. Subbaiyaa, LM No. 2427 as Honorary Warden of Indian Officers' Association with effect from 12-01-2021, until 02-10-2021 by the President(i/c) as per the provisions under Part III,clause 15 (iii) of the Bye-Laws of the Association.
- 9. The Executive Committee resolved to place Thiru S.Subbaiyaa, LM No. 2427, Hony. Warden, as General Manager (i/c) of Indian Officers' Association with effect from 12-01-2021 AN.till 02.10.2021.
- 10. The Executive Committee unanimously resolved to extend the services of the present Institutional Auditors and Statutory Auditor till 31.03.2021.
- 11. The Executive Committee took note of the fact that there is unspent amount in the sanctioned amount for the works related to Lounge of IOA. The Executive Committee unanimously resolved to provide Reclining Chairs, air conditioning and other facilities including a cloak room in the Lounge for the use of the members of the Association.
- 12. The Executive Committee resolved to defer the proposal to reopen the canteen services for the present as the Covid19 protocol has not been fully relaxed.
- 13. The Executive Committee took note that Thiru. Balasubra maniam, Assistant Cook and Tmt. Devaki, Supplier attached to the canteen of IOA, were provided with full salary from 25.3.2020 to 24.6.2020 and 50% salary from 25.6.2020 to 31.12.2020 on compassionate grounds, despite their services were not required during the closure period of the canteen from March,17, 2020 due to Covid protocol. The Executive

Committee resolved to approve the termination of both the staff members from the services of canteen attached to IOA. as the canteen is closed for nearly a year.

- 14. The Executive Committee unanimously resolved to obtain an opinion from Thiru.Arumuga Nainar, Additional expert Inspector General of Registration (Retd.) and Advocate, regarding Section 25 of the Tamil Nadu Societies Registration Act, 1975 and the activities of IOA in the context of the present Bye -Laws of the Indian Officers' Association.
- 15. The Executive Committee unanimously resolved to welcome the decision of the President (i/c) to convene the Special General Body Meeting on 21.02.2021 based on the representation of 65 Life Members of the Association.
- 16. Executive Committee. The resolved to accept the recommendation of Admission Sub Committee and to approve the following aspirants as Life Members of the Indian Officers' Association with effect from 12.01.2021.
