#### Agenda 4:

To ratify the appointment of an advocate in the case in O.S.No.4984/2021 and IAs in O.S.No. 4984/2021 filed by a member against IOA in respect of admission of new life members.

#### Resolution:

The Executive Committee unanimously resolved to ratify the appointment of R & P Partners as legal counsel to deal with the Civil Suit in O.S.No.4984/2021 filed by Mr. N. Meenakshisundaram (L.M.No.1660) against IOA in respect of admission of new Life members.

#### Agenda 5

Mr.R.S.Shrinivasan, in his capacity as General Secretary (In-charge) of Indian Officers' Association, has filed a civil suit in O.S.No.5403/ 2021 praying for an ad interim injunction to restrain the EC members of IOA from taking up any discussion pertaining to the termination of Thiru P. Kadhirvel from the Life Membership of IOA, and also restraining the EC Members of IOA against initiating any action against Thiru R.S. Shrinivasan, as the said termination was done in the official capacity as General Secretary (I/c) of IOA. The prayer of Mr. R.S. Shrinivasan, General Secretary i/c) also includes that the subject be placed before the ensuing Special General Body/ General Body for any further decision. Thiru R.S. Shrinivasan, General Secretary i/c substantiated his action by citing references to the decision of the General Body Meeting held on 26.01.2020 and the resolution of the Executive Committee held on 29.02.2020 directing to invoke clause 11(v) of the bye-law against the life member.

Discussion on action taken by the general Secretary(i/c) in the form of a proceedings dated 26-7-2021 (C.No.1253/IOA/FFC/2019) terminating the life membership of Thiru.P.Kadhirvel,  $\underline{L.M.No}$ . 310

#### Resolution

- (1) Resolved to take up this subject matter in the next EC Meeting after taking legal opinion on O.S.No.5403/2021 and IA No.3 in O.S.No.5403/2021 as the General Secretary (i/c) has filed a civil suit in O.S.No.5403/2021 and IA No.3 in O.S.No.5403/2021 by against the President of IOA to restrain the EC members of IOA for taking up any discussion pertaining to his proceedings relating to the termination of Thiru P.Kadhirvel from the life membership of IOA, and also restraining the EC members of IOA against initiating any action against Thiru R.S.Shrinivasan.
- (2) To the query raised by one of the Executive Committee member regarding the expenditure on the civil suit, Thiru R.S. Shrinivasan, clarified that eventhough the civil suit was filed in the capacity of General Secretary i/c in the interest of the decision of the General Body and the Resolution of the Executive Committee of IOA, the expenditure for the proceedings in the Court of Law on the petitioner's side would be borne by him.

6 (i). Requisition presented by 54 Life members urging to convene Special General Body Meeting to take decision on two proposed agenda items

#### Resolution:

The Executive committee discussed the matter in detail and resolved to take suitable action at the appropriate time keeping in view of the pandemic situation and expenditure involved in conducting such a meeting.

6 (ii). Case filed by Mr.Suresh, former Assistant Administrative Officer(AAO) IOA:

Mr. Suresh who worked as Assistant Administrative Officer (AAO) in IOA was dismissed from service as his services were found to be unsatisfactory and not up to the mark. He filed a case against his dismissal in the Labour Court and the case is now under trial.

#### Resolution:

The Executive Committee discussed the matter in detail and resolved to request Mr. R. Durai, Treasurer(i/c) / Executive Committee Member to talk with Mr. Jagannathan, Assistant Commissioner of Labour who is entrusted with the follow up of this case and take necessary action as may be necessary. The EC felt, that if necessary, Mr. Suresh may be reappointed as Assistant Administrative Officer(AAO) in the IOA subject to the condition that he will accept to get salary from the date of reappointment and not to demand sanction of arrears of pay from the date of his dismissal. Mr. R. Durai was requested to use his good office to have talks with both Mr.Jagannathan, Assistant Commissioner of Labour and Mr. Suresh, former Assistant Administrative Officer(AAO) in this regard.

6(iii) The General Secretary(i/c)'s action in issuing a proceedings C.No. 1253/IOA/FFC/2019 dated 26-7-2021 terminating Life membership of Prof. P.Kadhirvel, L.M.No310 by invoking clause 11(v) of Bye-laws without the approval of President(i/c) and the Executive Committee.

#### Resolution:

The subject matter was deferred and will be taken up for discussion in the next EC meeting after getting legal opinion.

6 (iv) The General secretary(i/c) refused to issue ID cards to some New Life members who were admitted on 9-7-2021 by the EC.

#### 6 (vii) The President i/c of IOA informed that:

- Flag hoisting ceremony will be held on the occasion of Independence Day on 15<sup>th</sup> August 2021 at 09.30 AM at IOA premises. He extended his invitation to all the EC members and all members of IOA to attend the function.
- Several agreement copies pertaining to several shops are remaining to be renewed and requested Mr. R. Durai, Treasurer (i/c) and the members of the rent collection committee to take suitable action for immediate renewal of all the pending agreements by fixing a time limit.
- The air conditioner machines installed in the Guest Rooms of IOA were in use for the last 10 years and needs to be replaced for efficient performance. The proposal put forth by Thiru P. Harikrishnan, Executive Committee Member was deferred.
- The Executive Committee meetings are being conducted through Zoom Conference facility for the last few months due to the pandemic. As it could not be conducted in an effective manner due to technical problems, the President (i/c) requested the members to attend the meeting in person. The President (i/c) assured that all precautionary measures will be taken for the safe conduct of the meeting in the spacious Thiruvalluvar Arangam of Centenary Building.
