To fix the date for Special General Body Meeting and finalizing the Agenda to purchase of Mementoes to the Life Members with reference to the letter received from the Registrar of Societies and to discuss the pros and cons of Section 25 (1) and (2) of Tamil Nadu Societies Registration Act, 1975.

The EC passed the following Resolutions after discussion.

- 1. Resolved to convene a Special General Body Meeting on 25.02.2023 at 10.30 A.M. in the Centenary Building Auditorium.
- 2. Resolved to place the following subjects in the Agenda for the Special General Body Meeting.

- v) To consider incidental expenses for those office bearers and EC Members for attending Regional Seminars and Regional Medical Camps.
- 5. Any other subject with permission of the Chair.
 - a) Resolved to conduct next Regional Seminar at Salem on 25.03.2023 (Saturday).
 - b) Allotment of 2700 Sq.ft. in the 2nd floor of JPS Complex to Green Trends.

2,700 sq.ft in the 2nd floor of JPS Complex was allotted to Green Trend in the EC Meeting held on 12.01.2023 at the rate of Rs.50/- per sq.ft. per month. However, the Green Trends represented by the Managing Partner stated that the rent fixed for the allotment is too high and requested to reduce the rent as Rs.35/- per sq.ft. per month.

The EC after detailed discussion accepted the representation given by the Green Trends and resolved to allot 2,700 sq.ft. in the 2nd floor of the JPS Complex at the rate of Rs.35/- per sq.ft. per month.

c) Hindustan Trading Company has also given representation to reduce the rent from Rs.40/- to Rs.35/-sq.ft. per month for the allotment of 2,000 sq.ft. in the 2nd floor of JPS Complex.

The EC after detailed discussion accepted the representation given by the Hindustan Trading Company and resolved to allot 2000 sq.ft. in the 2^{nd} floor of the JPS Complex at the rate of Rs.35/- per sq.ft. per month.

The EC considered their request and resolved to fix the rent as Rs.3,558/- per month without any increase as the Association is functioning as non-profitting organization and for the development of Tamil Language.
