- (iv) Thiru. John Fernandez, the tenant of Shop No. 111, IF, JPS
  Complex has to pay rental arrears of Rs. 4,26,467/-and
  interest on rental arrears of Rs. 2,20,871 as on 30 April,2025.
  A court case was filed in the city civil court (O.S. No.6979 of
  2022). The General Secretary took part in the Mediation in the
  High Court Complex as directed by the Court. Now, the tenant
  gave a letter dated 14-05-2025, agreeing for clearing the
  entire arrears in 8 installments spanning over 2 years of
  period. Now, he pays monthly rent regularly. The EC resolved
  to continue and conduct the court case.
- (v) The EC resolved to file an appeal against the order dated 15-4-2025, issued by the Deputy Commissioner, Labour, Chennai-6 in respect of case No. PG.30/2024 filed by Thiru. M.Rajendiran, former Office Assistant, IOA.
- (vi) The EC resolved that consequent to the President's scheduled absence from the country from May 27, 2025,
  Vice President-I, Thiru. S.Rathinasabapathi, IPS (R), is hereby authorized to act as President in-charge from May 27, 2025, until the President resumes office upon return.
