### 10. Modfurn Cases.

## (i) C.S.No.528 of 2019.

The Executive Committee expressed its unlimited happiness over the winning of the Court Case C.S.No.528 of 2019. The court case was filed by IOA in the year 2017 against 1. M/s Modfurn Systems India Private Limited, 2. M/s Jayabharatham Furniture & Appliances (P) Limited in the High Court of Madras claiming rental arrears of Rs.6,22,68,474/- for the period from 01-08-2008 to 29-02-2016. However, the case was numbered in the year 2019. The Honourable High Court of Madras delivered the judgement on 03-01-2025. We have won the case. The judgement copy will be available shortly. The success in the very important case was due to tireless efforts of the past EC Members and mainly due to continued efforts of the present EC Members headed by our President. The EC profoundly thanked our Senior Counsel Sri. AR.L.Sundaresan and his team for the success.

### (ii) C.S.No.90 of 2021

The EC noted that the civil suit C.S.No.90 of 2021 is in the final stage in the Honourable High Court of Madras. The court case was filed by IOA in the year 2020 against 1. M/s Modfurn Systems India Private Limited, 2. M/s Jayabharatham Furniture & Appliances (P) Limited in the High Court of Madras claiming rental arrears of Rs.1,64,70,579/- for the period from 01-03-2016 to 31-10-2020.
